Marek's research area is quantitative studies of science and higher education research and policy. His focus is on international research collaboration, academic productivity, social stratification in science, and the academic profession.

Marek has published more than **200 papers and 8 sole-authored monographs**, including *Knowledge Production in European Universities*. *States, Markets, and Academic Entrepreneurialism* (Peter Lang 2013, 488 pp.), *The University and the State: A Study into Global Transformations* (Peter Lang

2006, 425 pp.). He has also published two other monographs only in Polish: *University Transformations*. The Institutional Change and European Educational Policies (2010, 447 pp.) and Universities in the Time of Change. Institutions and the Academic Profession under Increasing Competition (2015, 544 pp.). His recent monograph was published by Routledge: Changing European Academics: A Comparative Study of Social Stratification, Work Patterns and Research Productivity (2019, 284 pp.).

He publishes in **leading international journals**, including *Higher Education*, *Studies in Higher Education*, *Science and Public Policy, Comparative Education Review, Scientometrics, Journal of Studies in International Education* etc., as well as for global publishers (Routledge, Springer, Palgrave, Elsevier, Cambridge University Press).

Marek was a Principal Investigator in a highly selective five-year project: *Maestro: Program for International Comparative Research in Higher Education* (2012–2017), funded by the National Research Council (NCN). In 2015, he received a prestigious annual "Master Award" from the Foundation for Polish Science (FNP) and in 2018 he received a national annual "Internationalization Star" award. In 2017, he received one of three annual awards for "**Outstanding Contribution to Science**" from the Ministry of Science in the category of "Impact on the Development of Society."

He has been advising extensively to national governments, international organizations and global consulting firms on **university funding & governance reforms and science policy in 13 countries** (Ukraine, Belarus, Poland, Latvia, Bosnia and Hercegovina, Slovenia, Kosovo, Macedonia, Slovakia, Hungary, Moldova, Georgia, Kyrgiz Republic – for OECD, OECD/IMHE, World Bank, USAID, Council of Europe, European Commission, European Parliament, UNDP, OSCE, as well as Ernst & Young and PriceWaterhouseCoopers). His recent policy report is "The International Collaboration of EU Research Organizations" published by the European Parliament (114 pp., 2019).

Since 2000, Marek has been a Principal Investigator or country Team Leader in **25 international higher education research projects** (global and European) funded by the European Commission (6th and 7th Framework Programs); the European Science Foundation (ESF); and the Fulbright, Ford, and Rockefeller foundations. Marek was a partner in **several large-scale EU-funded comparative research projects:** *EDUWEL: Education and Welfare* (2009–2013), *WORKABLE: Making Capabilities Work* (2009–2012), *EUROAC: The Academic Profession in Europe* (2009–2012), *EUEREK: European Universities for Entrepreneurship* (2004–2007), and *GOODUEP: Good Practices in University-Enterprises Partnerships* (2007–2009).

Marek is highly internationalized in research. He is one of few Polish double Fulbright scholars who spent three years at North American universities as a Fulbright Foundation scholar (University of Virginia, Charlottesville) and Kosciuszko Foundation scholar (University of California, Berkeley) and the only Polish Reagan-Fascell Democracy Fellow (National Endowment for Democracy, Washington, DC). He was also a Fulbright New Century Scholar (NCS) from 2007 to 2008 ("Higher Education in the 21st Century;" the only Polish academic in the NCS program under D. Bruce Johnstone, SUNY Buffalo) and a Professorial Visiting Fellow at the Institute of Education, London, from 2012 to 2013. Marek was also

awarded a prestigious Library of Congress fellowship and became a Kluge Fellow 2002-2003 in Washington, DC; however, he chose to spend the same period as a Reagan-Fascell Democracy Fellow.

Marek is also an **editorial board member** for *Higher Education Quarterly*, *European Educational Research Journal*, *British Educational Research Journal*, and *European Journal of Higher Education* as well as for a Springer book series, *Higher Education Dynamics*. He has been heavily involved in peer-reviewing for the higher education research and policy community, Clarivate's publons.com portal showing 85 peer-reviews in the past few years.

In the last decade, he has presented papers, invited lectures and keynotes at approximately 80 international conferences and seminars across Europe and globally.

He has been heavily involved in higher education reforms in Poland and across Europe. He co-authored the Polish *National Strategy for the Development of Higher Education until 2020* (Ernst and Young 2010), *Europe 2020 Poland* report (World Bank 2011), and *National Strategy for the Development of Higher Education in Ukraine until 2022* (USAID 2014). He also co-authored a European analytical tool to measure innovation of European universities for the European Commission and the OECD (2012): *heinnovate* (heinnovate.eu). Marek was the head of a 10-member national team preparing recent Polish higher education reforms ("Law 2.0," 2016–2017). Currently, he is heading a team of 10 scholars preparing reforms of the student financial aid system (2019-2021). He also co-authored a successful AMU Development Plan 2020-2026 within the Polish "Excellence Initiative" (for 100 million USD) and has been a vice-chairman of this project since 2019. For collaborative research projects he directed over the past ten years, he received 2.5 million euro and employed 15 young scholars in the Center.

His 2019 Routledge book and selected papers were reviewed in *Nature*'s editorial (2017), *Higher Education Quarterly* (2020), *Higher Education Evaluation and Development* (2019), and three times in global *Times Higher Education* (2015, 2018, and 2020).
