MAREK KWIEK (born 1966). Professor (full) and Founding Director of the Center for Public Policy Studies (since 2002), Chairholder, UNESCO Chair in Institutional Research and Higher Education Policy, University of Poznan (<a href="www.cpp.amu.edu.pl">www.cpp.amu.edu.pl</a>) and Founding Director of the newly opened (2021) Institute for Advanced Studies in Social Sciences and Humanities, University of Poznan (AMU), Poland. ORCID: 0000-0001-7953-1063.

Marek's research area is **quantitative studies of science & sociology of science**. His focus is on international research collaboration, academic productivity, stratification in science and global academic elites. He has been advising extensively to national governments and international organizations on university funding & governance reforms and science policy in 15 countries (OECD, World Bank, USAID, Council of Europe, UNDP, OSCE, E&Y and PWC). His recent research report is "The International Collaboration of EU Research Organizations" for the European Parliament (114 pp., 2019).



Since 2000, Marek has been a Principal Investigator or country Team Leader in **25 international higher education research projects** (global and European) funded by the European Commission (6<sup>th</sup> and 7<sup>th</sup> Framework Programs); the European Science Foundation (ESF); and the Fulbright, Ford, and Rockefeller foundations. His research focus is university funding and governance, public sector reforms, and the changing academic profession. Marek was a partner in **large-scale EU-funded comparative projects:** *EDUWEL: Education and Welfare* (2009–2013), *WORKABLE: Making Capabilities Work* (2009–2012), *EUROAC: The Academic Profession in Europe* (2009–2012), *EUEREK: European Universities for Entrepreneurship* (2004–2007), and *GOODUEP: Good Practices in University-Enterprises Partnerships* (2007–2009).

Marek has published approximately **220 papers and 8 sole-authored monographs**, including *Knowledge Production in European Universities. States, Markets, and Academic Entrepreneurialism* (2013, 488 pp.), *The University and the State: A Study into Global Transformations* (2006, 425 pp.). His most recent monograph is *Changing European Academics: A Comparative Study of Social Stratification, Work Patterns and Research Productivity* (London and New York: Routledge, 2019, 284 pp.). He publishes mostly in **leading international journals**, including *Science and Public Policy, Comparative Education Review, Higher Education, Studies in Higher Education, Scientometrics, Journal of Informetrics, Journal of Economic Surevys, Journal of Studies in International Education*, etc.

Marek was a Principal Investigator in a highly selective five-year project: *Maestro*: *Program for International Comparative Research in Higher Education* (2012–2017), funded by the National Research Council (NCN). In 2015, he received a prestigious annual "Master Award" ("Mistrz") from the Foundation for Polish Science (FNP). In 2017, he received one of three annual awards for "Outstanding Contribution to Science" from the Minister of Science in the category of "Impact on the Development of Society."

Marek is highly internationalized in research. He is one of few Polish double Fulbright scholars who spent three years at North American universities as a Fulbright Foundation scholar (University of Virginia) and Kosciuszko Foundation scholar (University of California, Berkeley) and the only Polish Reagan-Fascell Democracy Fellow (National Endowment for Democracy, Washington, DC). He was also a Fulbright New Century Scholar (NCS) from 2007 to 2008 ("Higher Education in the 21st Century;" the only Polish academic in the NCS program) and a Professorial Visiting Fellow at the Institute of Education, London, from 2012 to 2013. Marek is also an editorial board member for *Higher Education Quarterly*, *European Educational Research Journal*, British Educational Research Journal, and European Journal of Higher Education. In the last decade, he has presented papers and keynotes at approximately 80 international conferences and seminars across Europe and globally. He was awarded 3 million euro in research grants.

He co-authored the Polish *National Strategy for the Development of Higher Education until 2020* (Ernst and Young 2010), *Europe 2020 Poland* technical report (World Bank 2011), *National Strategy for the Development of Higher Education in Ukraine until 2022* (USAID 2014); a European analytical tool to measure innovation of European universities for the European Commission and the OECD (2012): *heinnovate* (heinnovate.eu). Vice-chairman for research of a 100 million USD IDUB national excellence project (2020-2025) and co-author of the successful IDUB proposal (2018-2019).

In 2020, Marek was listed among top scientists cited in 2019 in Scopus (the upper 2% of scholars globally, field-normalized ranks), ranked 1,075 among 58,316 in the subfield of Education (Ioannidis et al. 2020, <a href="https://doi.org/10.1371/journal.pbio.3000918">https://doi.org/10.1371/journal.pbio.3000918</a>). In 2021, Marek was also listed among the 2%, and was ranked higher, about top 500 in Education globally.
